### NEED TO KNOW

- **REGISTRATION** must be completed before practice or play. Player Registration will be located in the Members Lounge & Caddie Registration will be located outside the Ballroom (Player & Caddie Dining). Hours of operation are listed above. Locker room fee is \$20 and club repair fee is \$25.
- **FOLDS OF HONOR** Friday July 25<sup>th</sup>, a short Presentation of Colors will be conducted at the practice putting green. The presentation accompanied by the playing of the National Anthem will take place at approximately 11:30 am, and will not delay play. Players on the practice putting green will be asked to pause for the approximately 3 minute presentation. **Players and Caddies are encouraged to wear red, white, and blue.**
- **PHYSICAL THERAPY** is located in upstairs in the Hotel Foyer, and may be accessed by the stairs outside the Member Lounge or using the elevators in the hall.

- **CLUB STORAGE** is not available.
- **LOCKER ROOM** facilities and shoe cleaning are available. Each player will have their own locker assigned by name plate, but keys will not be distributed. Golf Bags may NOT be left in the Locker Room overnight. Neither the club or the tournament are responsible for items left in the locker room. Locker Room Attendants hours will be 7:00 am – 7:00 pm daily.
- **FITNESS CENTER** is not available at The Glen Club. A nearby alternative, low cost (\$10/day or \$20/week) option will be available. Information to be available at Player Registration.
- **MONDAY PRO-AM** There will be a field of approximately 26 teams for the RSM Pro-Am. Play will be off #1 & #10 from 12:00 pm – 2:12 pm. Practice rounds are available off #1 and #10 tees beginning at 7:00 am. No play may begin off Hole #1 or #10 after 11:30 am. 1<sup>st</sup> & 10<sup>th</sup> tees will be available again at 5:00 pm, play must remain one hole behind the Pro-Am.
- **OFFICIAL PRO-AM** The Rewind Golf Pro-Am will take place on Wednesday, July 23<sup>rd</sup> as a 9 & 9 format with starting times from approximately 6:45 am to 8:57 am and 12:05 pm to 2:17 pm. There will be a field of approximately 52 teams. 9-hole practice rounds will be available from #1 and #10 tees until 6:30 am and must NOT interfere with the Pro-Am. Practice rounds are NOT permitted after the official pro-am.
- **PRACTICE ROUNDS** beginning on Hole #10 must yield to players making the turn and must not delay practice rounds already in progress. Abuse of Practice Area Policy may result in disciplinary action.
- **MEDICAL** First Aid/EMS is located on-site all week, in the parking lot. The tournament will have a doctor in Player and Caddie Dining all week.
- **PLAYER PARKING** will be located in the main clubhouse parking lot. Players will receive a Lot A parking pass at Player Registration that must be displayed to park in Lot A.
- **PLAYER & CADDIE DINING** will be located on the main level of the clubhouse, in the Ballroom, and will be open to players and one spouse/significant other (including children) with a TOUR issued credential (hours listed above), and caddies. **NOTE:** Additional player family will be able to purchase daily dining passes for \$40/day at the Front Desk located in the Clubhouse Lobby.
- **CADDIE PARKING** is located in Lot B, directly adjacent to The Glen Club clubhouse. Access to Lot B is at the intersection of Lake Ave and Valor Drive, just east of the clubhouse parking lot. Parking pass will be required and is obtained at Caddie Registration.
- **YARDAGE BOOKS** will be available free of charge at Player and Caddie Registration. Players and caddies MUST use the 2022, 2023, 2024 or 2025 Committee Approved Books.
- **SHORT GAME AREA** at the back of the range, is available for use by players. The tee deck adjacent to the Short Game Area is closed, and not available for use. Any use of this tee will be subject to disciplinary action.

- **SHUTTLES TO #10 TEE** will be available from the back of the Practice Range, Monday-Friday at the times highlighted on the tournament week schedule below. Players should allow ample time to arrive at the 10<sup>th</sup> tee for their starting time. Return shuttles for players concluding play on #9 will be available during applicable tournament rounds.

The Glen Club is progressing well through late spring and early summer, promoting quality and consistent turf growth. The G-series bentgrass greens are in excellent condition, maintaining the smoothness and speed that they typically provide. All other short grass areas are healthy, ensuring good playability and consistent lies during the event. The bluegrass rough is uniform and vigorous throughout. The bunkers at the Glen Club have been renovated using the Better Billy Bunker construction method, now ensuring proper drainage during rains and consistent playability. The Agronomy team has diligently compacted and prepared the bunkers daily in anticipation of this summer's event.

**Quick Facts:**

The target greenspeed will be in the range of 11.5 - 12'.

The tees and approaches will be mowed at 0.350".

The fairways will be mowed at 0.400".

The intermediate rough will be mowed at 1.25 inches, and the primary rough will be maintained at 3 inches.
